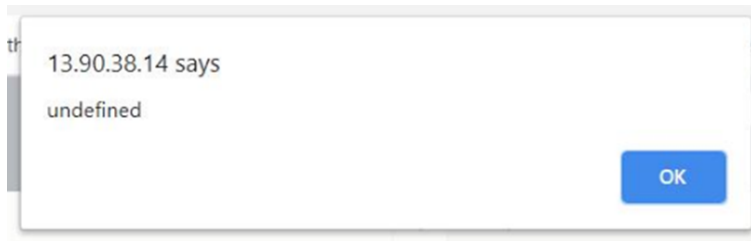

PPP Loan Origination Portal Error FAQ

Can't find the loan number from your original PPP loan with First Home Bank? The loan number is located in the closing documents signed during round 1. If you cannot locate them, try searching your inbox for the closing documents, the Loan Number was in the subject line and was sent from pppclosingteam@firsthomebank.com. The email subject line was something like, Please DocuSign: XXXXXXXXXX_BorrowerName.pdf. If you are still unable to locate your loan number, please email SBA Relief SBARelief@creditbench.com to request it, include the name of the borrowing business/individual and last 4 digits of the borrower business/individual's tax ID.

Receiving an undefined error? The below error is a system time-out for security purposes. If this error is received, click OK and try logging in again.



Having ownership input issues? The system will calculate the total ownership for the business by adding the input for each individual owner. The input cannot be 0% or have a total of more than 100%. If your company has multiple owners, list each owner and their individual percentage of owner's equity in the company. (I.e. if John and Suzy Baker own XYZ Company, John and Suzy cannot both be 100% owners as that totals 200%; If they are equal partners, then each would list 50% ownership)

Operating as a non-profit and aren't sure how to complete the ownership section in the portal? For non-profits, you should enter 20% ownership and enter the non-profit as the borrower and principal.

Having issues uploading documents? The problem is related to Internet bandwidth and increased volumes of traffic to the portal; large file sizes may also be creating this issue. A work around is uploading each document individually and waiting until each document is loaded or to upload a blank document, naming it “blank” for all these files. If the latter option is chosen, please email your business name and PPP loan number with the attached documents, and we will upload them for you. Send the email to SBA Relief SBARelief@creditbench.com

Want to verify your application once submitted? First log back in to the portal, it should show Verification in Progress without the edit or delete function. Once an application is submitted an applicant can no longer edit or make changes to the application. If changes to the application are needed, email SBA Relief SBARelief@creditbench.com.
