<u>Sponsor/Administrator</u>: The sponsor and administrator of this Sweepstakes is BAYFIRST ("Sponsor" or "Administrator"), whose corporate address is 700 Central Avenue, Saint Petersburg, Florida 33701 and whose website is www.BayFirstFinancial.com.

Eligibility: This Sweepstakes is only open to individuals who are citizens of the United States of America, eighteen (18) years of age or older, and who submit their information via business card or on the entry form provided by Sponsor. Entries submitted by ineligible entrants are void. Employees of BAYFIRST, members of BAYFIRST's Board of Directors, and their immediate family members are not eligible to enter or win. Sponsor may require each winner to fill out an affidavit indicating the winner's name and attesting to his or her age, date of birth, and address.
