In the event conflicting written notices are received by First Home purporting to be on behalf of, and purportedly signed by an Officer, Manager, or General Partner of the Borrowing Business growing out of or relating to any change, amendment or rescission of these resolutions, the Borrowing Business expressly agrees and consents that First Home, without owing any liability whatsoever to the Borrowing Business, its agents, employees and stockholders, or any third parties, may, but is not required to, withhold, restrict and impound all or any part of the deposits, money or property of the Borrowing Business in its hands and immediately thereafter may refuse to honor any and all demands for the payment of checks or other instruments drawn by the Borrowing Business and subsequently presented to First Home for payment, or for the withdrawal of any such deposits or monies and may subsequently file a suit in interpleader and the Borrowing Business hereby declares to assent to the passing of an Order by

the Court requiring the parties sending such written notices and the Borrowing Business to interplead and litigate in such Court their several claims and rights among themselves.

FURTHER RESOLVED, that any Authorized Signer of the Borrowing Business shall be and he/she is hereby authorized and directed to deliver and certify to First Home a certified copy of these Resolutions and that the same are in conformity with articles of incorporation and bylaws (of Corporation), articles of organization and operating agreement (of LLC), or Partnership Agreement (Partnership), the Borrowing Business together with a certificate setting forth the names and certifying to the signatures of the present Authorized Signers of the Borrowing Business, and First Home shall be free from liability and fully protected in relying on such certifications of such Authorized Signer and shall be indemnified and saved harmless from any claims, demands, expenses, loss or damage resulting from, or growing out of, honoring the signature of any Authorized Signer so certified, or refusing to honor any signature not so certified.
